Our mission is to celebrate our community's heritage, arts, and culture through research, preservation, interpretation, and exhibitions.





THE STORY OF DESBRISAY MUSEUM

Our museum traces its roots to 1860, when a young lawyer, Mather Byles DesBrisay, started a private artifact collection. By 1880 this collection had grown to such proportions that it attracted the attention of local citizens, students, and tourists, and was considered to be the definitive local museum.

Following the death of Judge DesBrisay in April 1900, the collection was purchased by Mayor E.D. Davison from Mrs. DesBrisay and presented to the Town of Bridgewater.

In 1966, the collection was moved to Bridgewater's completed Centennial Project and the museum's current home on Jubilee Road.

Over the past 50 years, the museum has continued to grow thanks to the support of the Town of Bridgewater and the generosity of donors and volunteers – folks who desire to preserve our heritage while promoting art and culture in our community.

A gift of more than \$25,000 could help to establish a Named Endowment Fund as a permanent investment fund at the museum.




THE MUSEUM AS BENEFICIARY

For a small legal fee, you can add a codicil, or an amendment, to your existing will. Again, we advise you to contact your lawyer or financial advisor for more information.

We ask that all donors who have made a planned gift contact museum staff to record of the commitment.
